1.5 Approve the 2018 - 2019 School District Budget -

BE IT RESOLVED upon the recommendation of the Superintendent of Schools that the South Brunswick Board of Education approve the FY 2018 - 2019 school district budget as follows:

BE IT FURTHER RESOLVED whereas, School District Travel Policy 6471 and NJAC 6A:23B-1.2 (b) provides that the Board of Education shall establish in the annual school budget a maximum for 2018 - 2019 school year.

NOW THEREFORE BE IT RESOLVED, that the South Brunswick Board of Education hereby establishes the school district travel maximum for the 2018 - 2019 school year at the sum of \$150,000.

BE IT FURTHER RESOLVED that the School Business Administrator shall track and record these costs to insure that the maximum amount is not exceeded.

1.6 Approve Resolution for Enrollment Adjustment Waiver – upon recommendation of the Superintendent of Schools that the Board of Education approve the following Enrollment Adjustment Waiver Resolution for the 2018 – 2019 school district budget:

WHEREAS, the South Brunswick Board of Education has the ability to use an enrollment adjustment waiver in the general fund tax levy to balance the budget for 2018-2019; and

WHEREAS, the Board of Education will be using \$543,273 from 2017-2018 in an enrollment adjustment waiver in order to balance the general fund for the 2018-2019 budget to, maintain existing programs, implement mandated programs, and remain in alignment with the district's strategic plan; and

WHEREAS, the Board of Education adopts a resolution to use enrollment adjustment waiver in the 2018-2019 budget; and

WHEREAS, the district is going above the 2% tax levy cap with the additional tax levy enrollment adjustment of \$543,273.

1.7 Approve Resolution for Lease Purchase – upon recommendation of the Superintendent of Schools that the Board of Education approve the following resolution for lease purchase as per the following:

Resolution of the Board of Education of the Township of South Brunswick in the County of Middlesex, determining to finance the acquisition of (5) 54 Passenger School Buses and (2) 19 Passenger plus 3 Wheel Chair Position School Buses through the cooperative bid process, recommendation of award and execution of a lease purchase agreement, approving the form of certain agreements including a lease purchase agreement, authorizing certain officials of the board to execute such agreements and authorizing other actions necessary to accomplish the transaction.

WHEREAS, The Board of Education of the Township of South Brunswick in the County of Middlesex, New Jersey (the “Board” when referring to the governing body, and the “School District” when referring to the legal entity and the territorial boundaries that are governed by the Board) has determined to lease purchase finance the acquisition of (5) 54 passenger school buses, (2) 19 passenger plus 3 wheel chair position school buses and other miscellaneous costs required to enter into a Lease Purchase Agreement (“Lease, Agreement”) for an amount of approximately \$635,134.86 (collectively, the “Acquisition”); and

WHEREAS, The Board has selected The Hunterdon County Educational Services Commission to serve as financial advisor (the “Financial Advisor”) to conduct a competitive bid (BID) for the Lease Purchase to finance the cost of the Acquisition; and

WHEREAS, The Hunterdon County Educational Services Commission has conducted the Competitive Bid for the Lease Purchase on April 24, 2018 and has made a recommendation of award to the Board;

WHEREAS, The Board wishes to expedite the payment of the respective vendors of the Acquisition;

NOW THEREFORE BE IT RESOLVED by the Board of Education of the Township of South Brunswick in the County of Middlesex, as follows:

The Board hereby awards the lease purchase transaction to US Bancorp Government Leasing & Finance, Inc., and approves the execution of the Lease to the Lessor in order to finance the Acquisition and authorizes the sale of the Lease to US Bancorp Government Leasing & Finance, Inc. as Lessor, after Board Counsel has reviewed the Agreement. This award is to be made in accordance with the proposal form submitted by US Bancorp Government Leasing & Finance, Inc. to the Board Secretary as of the date of the Bid; said proposal shall be attached hereto, and kept on file with the Board Secretary.

The Board hereby awards the lease purchase transaction to US Bancorp Government Leasing & Finance, Inc. at an interest rate of 3.1744% for the five-year schedule to the lease. Should this lease not fund prior to June 20, 2018, this interest rate may be adjusted according to the following terms:
