Sayvon Jarrett finished 4th in discus with a mark of 163 (feet) (and) 3(inches) and 5th in Shot Put with a mark of 50 (feet) (and) 1 (inch) to qualify in 2 events as well.
- The Girls Track team finished in 3rd place at the State Group IV Championships. Courtney Campbell won the State title in the high jump and Olivia Scattergood finished 2nd in discus and also broke the school record. A total of 14 girls qualified to compete at the NJSIAA meet of Champions.


